Judges, prosecutors, and probation officers can divert youth and young adults who have committed a crime from the traditional path of criminal justice - conviction, criminal record, and in some cases incarceration - to Community Resolution Conferencing. In these circles, victims talk about the damage that was caused and the impact on their lives. The offenders tell what happened and take accountability for the harm they caused. With the help of community participants, they reach consensus on how offenders can repair the harm they have caused. When the offenders complete these agreements, usually with the help of an RJP volunteer mentor, the court typically reduces or dismisses the charges.

4b (Code:) (Expenses \$ **90,963.** including grants of \$) (Revenue \$)

The Long Creek Juvenile Facility initiative provides education and training in Restorative Justice Practices to staff at this, the only juvenile facility, in Maine (located in Portland). Restorative Justice Practices also works with juveniles returning to their home communities throughout Maine to provide re-entry 'circles' of support and accountability, along with victim offender dialogue and infraction circles. Long Creek Juvenile program has a 19 month contract with Maine Department of Corrections. Started December 2015-Actual work began January 2016. We provide training to correction officers and juveniles in restorative practices. Provide mentors for released juveniles. Total contract for 19 months is \$ 152,204. This past fiscal year we received the remainder of the contract.

In partnership with the Maine Coastal Regional Reentry Center, the Waldo County Sherriff's Office and Volunteers of America, RJP applies the principles and practices of restorative justice to build trust and relationships among men and staff in the Center and in the community of Belfast and the surrounding area. At any given time, up to 32 resident men complete a rigorous application and selection process to finish the final eight to twelve months of their sentences at the Center. We match these residents with mentors from the community, teach them restorative justice and facilitate circles to address issues and resolve conflict.
