The Long Creek Juvenile Facility initiative provides education and training in Restorative Justice Practices to staff at this, the only juvenile facility, in Maine (located in Portland). Restorative Justice Practices also works with juveniles returning to their home communities throughout Maine to provide re-entry 'circles' of support and accountability, along with victim offender dialogue and infraction circles. Long Creek Juvenile program has a 19 month contract with Maine Department of Corrections. Started December 2015-Actual work began January 2016. We provide training to correction officers and juveniles in restorative practices. Provide mentors for released juveniles. Total contract for 19 months is \$ 152,204. This past fiscal year we received the remainder of the contract.
