MCRRC: For more than 10 years, RJP Maine has provided Restorative services to the Maine Coastal Regional Reentry Center through a unique collaboration with the Waldo County Sherriff and Volunteers of America. We train and support the MCRCC staff and residents to use restorative practices within the institution as a non-adversarial, solution focused way to problem solve conflicts and infractions. RJP Maine provides group programming for all residents at the center and jail. 95% of residents have participated in introduction to Restorative Justice. Recidivism for the center is 27% compare to statewide average of 58%. MCRRC is providing Restorative practice classes and mentors for the residents-a \$42,000 contract with Volunteers of America. Additional income from donations.

Restorative Justice Project Maine facilitates compassionate responses to crime and wrong doing that fosters support and healing for the victim; accountability, intervention and reintegration of the offender: and renewal and safety for the community.

MYC also has a contract for \$365,000 with the DOC providing similar programs in the Portland and Lewiston Maine area.
